Residents and visitors will have the choice to access the natural world, places of business and healthy recreation options without the need for a car. FOP will be a positive force toward achieving this vision.

Letter from our leadership

It's been quite a year for Friends of Pathways. While we could fill this letter with a list of pandemic-related challenges, we are instead going to highlight noteworthy trends and projects of 2020, the wildly important goal that drives our future, and your critical role in both.

Access to open space, exercise, nature and fresh air were in high demand in 2020, and our local trails and pathways delivered. The numbers of visitors and locals on foot and bike was simply astounding. Counters notched record usage, with most showing 20-50% increases from the previous year.

FOP staff spent over 5,000 hours in the field working to improve public access, and user education and experience along Jackson's vast backyard trail and pathway network.

2020 Trail & Pathway Projects:

- Cache Creek Single-Track Winter Grooming
- Old Pass Road Restoration (in partnership with Teton County and Jim Verdone/Team Jackson Hole)
- Summer Youth Trail Crew Program (9 crew members)
- Adams Canyon connector trail (started)
- Game Creek Road connector trail (almost complete)
- Pine Drive connector trail (completed)

- Cache Creek rehabilitation and repair
- Blair Drive Bike Park enhancements
- Pathway radar signs (purchased and used along high-conflict areas)
- Over 400 bike bells distributed or installed
- Over 300 trees cleared from trails

The Jackson Hole community will be better served when Every Neighborhood is Connected to the pathway and trail network. Over 800 comments were collected on the Teton Mobility Project Survey Map. This public input will help guide the next decade of investment in walk and bike infrastructure.

We have been so thankful for FOP friends and supporters this year. The notes of encouragement, the donations, the smiles, the ice cream 🍦 – our Friends are amazing and invigorate the staff and Board beyond words. Simply put, YOU make everything possible.

We hope that our paths will cross in 2021 and we can resume our in-person activities. Until then, please stay healthy, and all the best for a new year with ample time to get outside and enjoy the great outdoors.

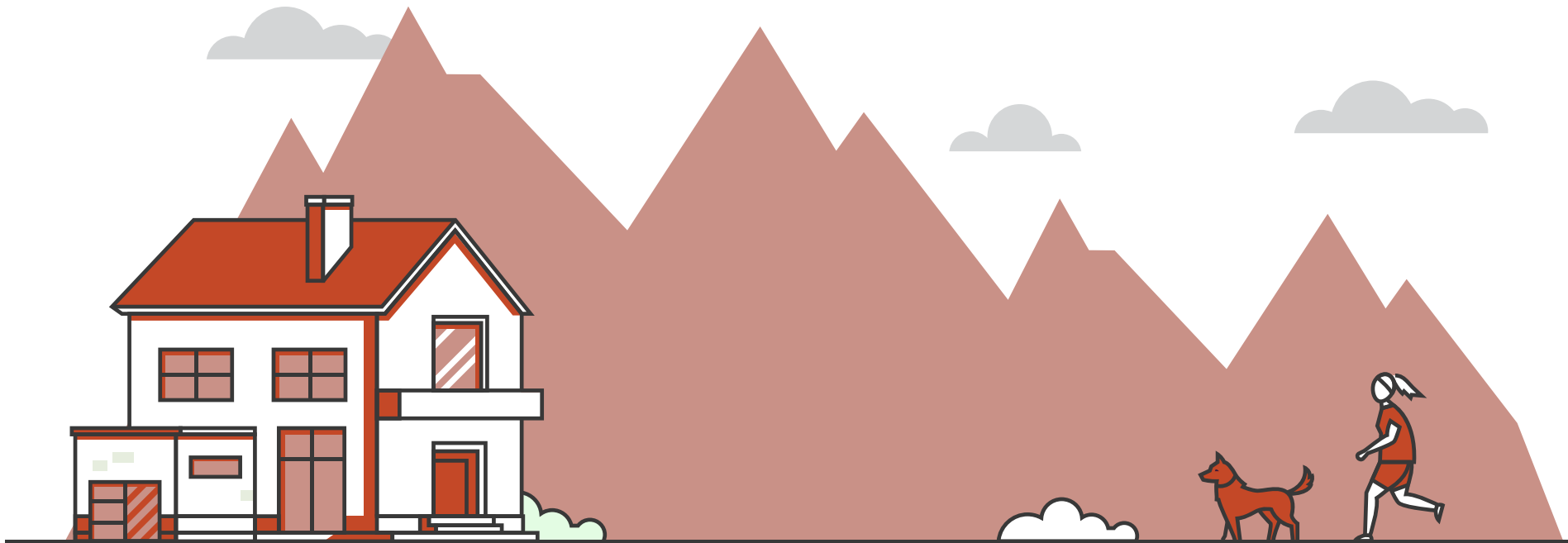

HOW IT WORKS:

- 1 Public comment was collected via an online interactive mapping tool from May–September 2020.
- 2 Alta Planning + Design analyzed the findings and crafted a series of recommendations based on the public feedback.
- 3 FOP and JHCP will present findings at a Town and County Joint Information Meeting in 2021.
- 4 Public and professional input will help create a priority projects list for adoption by the Town and County. The list will direct the development of pathways, sidewalks, and on-street bike lanes for the next 5 to 10 years.

“The existing sidewalks are piecemeal and most of the time I find myself walking down the middle of a street with no sidewalks.”

“I am especially worried about my children once they leave the path on Snow King and ride into town.”

“Many roots have grown across the pathways and are dangerous for bikes.”

“A safe crossing to Wilson Elementary School would be very beneficial to all residents and families who live on the south side of Hwy 22 between Wilson and the Snake River...”

“It feels unsafe that the Broadway bike path disappears as it approaches the 5-way intersection at Ace Hardware. I would love to see a bike lane created to help get bike commuters safely through town.”

“A pathway connection from Golf & Tennis and the South end of Spring Gulch would be so valuable.”

“Think big and create bike paths between all our surrounding communities including Alpine, Victor, Bondurant, and Dubois.”

“The Buffalo Way intersection is confusing for motorists and cyclists, and the place I feel less safe.”

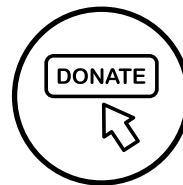

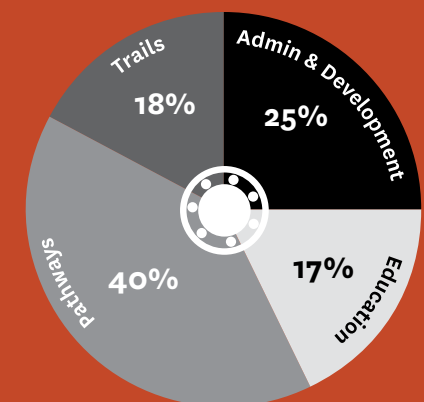
FY2020*
